**BALANCE OF GAME FEES:** For receipting purposes, the Club/Team delegate initiates the balance of payment to CSSA for all teams within their Club, by completing the Team Reconciliation Form. **Payment of Balance to Game Fees for all Teams - due 25 JUNE 2022**
